

AMBASSADOR AGREEMENT

This Ambassador Agreement ("Agreement") is entered into as of [Date], by and between Hybrid Learning Ocean (Malaysia) Sdn Bhd, located at [Company Address] ("Company"), and [Ambassador Name], located at [Ambassador Address] ("Ambassador").

1. Purpose

The Company appoints the Ambassador to promote its programs, including but not limited to the Global i-Learning Movement (GiM), and any future packages, as described in this Agreement. The Ambassador must meet certain requirements to qualify and be entitled to additional compensation.

2. Term

This Agreement shall commence on [Start Date] and shall continue for a period of [Duration], unless terminated earlier in accordance with the terms of this Agreement.

3. Qualification Requirements

To become a qualified Ambassador and be entitled to additional compensation, the Ambassador must fulfill the following requirements:

1. Be active on any social media platform with at least 100,000 followers or subscribers.
2. Maintain a good and positive public image. The content on social media must be positive.
3. Accumulate at least 1,000 direct GiM referred subscribers.

4. Scope of Services

The Ambassador agrees to perform the following services ("Services"):

- Promote the Company's programs through various social media platforms, including but not limited to [List of Platforms].
- Create and share content such as posts, stories, videos, and blogs that highlight the Company's programs.

- Attend and promote Company events, webinars, and other promotional activities as agreed upon.

5. Content Requirements

The Ambassador agrees to the following content guidelines:

- All content must be original and created by the Ambassador.
- Content must be honest, authentic, and reflect the Ambassador's true opinion.
- Content must include any required disclosures, such as #ad or #sponsored, in accordance with applicable laws and regulations.
- Content must be "Clean and Positive", ensuring that it is free from offensive language, hate speech, and negative commentary.

6. Compensation

In consideration for the Services, the Company agrees to pay the Ambassador as follows:

- USD 3 per Global i-Learning Movement (GiM) subscription directly referred by the Ambassador.
- An additional USD 1.2 per GiM subscription directly referred by the Ambassador upon meeting the qualification requirements.
- Payment terms and schedule: Payments will be made monthly, within 15 days after the end of each month, based on the number of confirmed subscriptions referred by the Ambassador.

7. Confidentiality

The Ambassador agrees to keep confidential any proprietary information, trade secrets, or other sensitive information disclosed by the Company during the term of this Agreement.

8. Intellectual Property

- The Company retains all rights, title, and interest in its trademarks, trade names, logos, and other intellectual property.
- The Ambassador grants the Company a non-exclusive, royalty-free, worldwide license to use, reproduce, and distribute the content created by the Ambassador for promotional purposes.

9. Termination

Either party may terminate this Agreement upon 60 days' written notice to the other party. In the event of termination, the Ambassador shall be paid for any Services completed up to the date of termination.

10. Representations and Warranties

The Ambassador represents and warrants that:

- They have the right to enter into this Agreement and to grant the rights granted herein.
- The content created will not infringe on any third-party rights.

11. Indemnification

The Ambassador agrees to indemnify and hold harmless the Company from any claims, damages, or expenses arising out of the Ambassador's breach of this Agreement or the representations and warranties contained herein.

12. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Malaysia.

13. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, and representations, whether oral or written.
